ORDINANCE NO. 150125

An Ordinance accepting five temporary sewer easements for the SW ARNOLD CREEK SANITARY SEWER PROJECT, granted by Frederick S. Hueneke and Florence M. Hueneke, Ben R. Jarrett and Elaine E. Jarrett, Barbara E. Nusbaum, Bruce L. Dunlap and Kristi A. Dunlap and Roger Snipes authorizing total payment of \$774.00 and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- Right of way is required for construction of the SW Arnold Creek Sanitary Sewer Project.
- Frederick A. Hueneke and Florence M. Hueneke, Ben R. Jarrett and Elaine E. Jarrett, Barbara E. Nusbaum, Bruce L. Dunlap and Kristi A. Dunlap and Roger Snipes have conveyed the required right of way to the City for the total sum of \$774.00.

### NOW, THEREFORE, the Council directs:

That the following described easements are hereby accepted for sewer purposes:

The east 12.5 feet of the following described tract in Lot 3, Galeburn Place, Multnomah County, Oregon, to wit:

Beginning at the intersection of the south line of Lot 3, Galeburn Place and the east line of SW 35th Avenue (formerly known as SW Stephenson Road); thence N.1°00"W. 152 feet along the east line of said SW 35th Avenue; thence east 85.13 feet; thence S.1°00'E. 152 feet to the south line of said Lot 3; thence west 85.13 feet to the point of beginning. (Granted by Frederick A. Hueneke and Florence M. Hueneke.)

AND ALSO

The east 15.0 feet of the north 40.0 feet of the following described tract:

That tract in Section 29, Township 1 South, Range 1 East of the Willamette Meridian, in the County of Multnomah and State of Oregon, described as beginning at the Southeast corner of said Section 29; thence North along Section line 979.6 feet; thence North 89°00'W. 661.2 feet to the Southeast corner of a tract conveyed to J.F. Levins by Thomas and Anna B. Connell and recorded in Deed Book 363 at page 81; thence following the Southerly line of said Levins Tract North 89°00'W. 330.6 feet to the Southwest corner of said tract; thence N.O°02'W. along the Westerly line of said tract 131.76 feet; thence S.89°00'E. 330.6 feet to the Easterly line of the said Levins Tract; thence S.0°02'E. 131.76 feet to beginning; Excepting therefrom the West 15 feet reserved for road purposes. (Granted by Ben Jarrett and Elaine E. Jarrett).

The south 10.0 feet of the following described tract:
