
Section 1. The Council finds:

- 1. That the City desires to have Stevens, Thompson & Runyan, Inc. perform the additional work necessary to complete the construction supervision services.
- That Agreement No. 16646 between the City and Stevens, Thompson & Runyan, Inc. established \$169,000 as the maximum compensation to the consultant, Ordinance No. 146318 increased this amount by \$12,582 for a total of \$181,582.
- 3. That Stevens, Thompson & Runyan, Inc. have used the maximum contract amount of \$181,582 and, due to extensive project delays, find that an additional \$11,400 is required to complete their contractual obligations.
- 4. That an \$11,400 increase in the maximum compensation to the consultant is appropriate for the additional work to be performed.
- 5. That this increase is 100% reimbursable under the terms of the Economic Development Administration Grant No. 07-51-26809.

NOW, THEREFORE, the Council directs:

a.
