ORDINANCE NO. 150112

An Ordinance amending Section 20.12.210, Parks and Recreation, of the Code of the City of Portland to provide that it is unlawful for persons to be in Kelley Point Park between the hours of 8 p.m. and the following 8 a.m. and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 20.12.210 of the Code of the City of Portland presently makes it unlawful for any person to be in a park any time between the hours of 12:01 a.m. and the following 5 a.m. subject to certain exceptions;
- 2. That by reason of certain provisions of the lease agreement between the City and the Port of Portland by which the City leases Kelley Point Park and further by reason of the location of Kelley Point Park and its proximity to the river and other relevant factors, it is desirable that Kelley Point Park be closed between the hours of 8 p.m. and the following 8 a.m.;
- 3. That Section 20.12.210 of the Code of the City of Portland should be amended to make it unlawful for persons to be in Kelley Point Park between the hours of 8 p.m. and the following 8 a.m.

NOW, THEREFORE, the Council directs:

a. Section 20.12.210 of the Code of the City of Portland is hereby amended to read as follows:

20.12.210 Hours of Park Closure. It is unlawful for any person to be in a park any time between the hours of 12:01 a.m. and the following 5 a.m. except that it shall be unlawful for any person to be in Kelley Point Park between the hours of 8 p.m. and the following 8 a.m. This Section shall not apply to the following, which are affirmative defenses:
