

ORDINANCE No. 150163

An Ordinance authorizing a contract with Pacific Diesel Power Corporation to furnish four Allison Transmissions to the Bureau of Fire, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds

- 1. Pacific Diesel Power Corporation located at 5061 N. Lagoon, Portland, Oregon was the lowest responsible bidder for furnishing four (4) Allison Transmissions for the Bureau of Fire at a cost of \$30,373.30.
- 2. Award of a Contract to said bidder for furnishing said equipment has been recommended by the Chief of the Bureau of Fire and approved by the Commissioner-in-Charge.

NOW, THEREFORE, the Council directs:

- a. The Auditor and the Commissioner of Public Works are authorized to execute a contract with the responsible bidder for the equipment described in Section 1 hereof in accordance with specifications filed with the Purchasing Agent on July 22, 1980.
- b. The Mayor and Auditor hereby are authorized to draw and deliver a warrant chargeable to the 1980-81 Budget, General Fund--Bureau of Fire AU (124), Logistics Division, RU (124), Object Code 640, when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the Contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
