ORDINANCE NO. 190373

*Authorize application to the Department of Homeland Security Urban Areas Security Initiative grant program for a grant up to \$3,800,000 to enhance emergency preparedness through planning, training, and equipping of emergency responders in the Portland Urban Area (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The Department of Homeland Security provides financial assistance to selected urban areas through the Fiscal Year (FY) 2021 Urban Areas Security Initiative (UASI) grant program. The UASI program assists highthreat, high-density Urban Areas to build, sustain, and deliver capabilities necessary to prevent, protect against, mitigate, respond to, and recover from acts of terrorism. Many of these capabilities also support Urban Areas in preparing for, responding to, and recovering from natural or human caused disasters.
- 2. The Department of Homeland Security has designated the City of Portland, Metropolitan Statistical Area (MSA) as the core urban area in the State of Oregon.
- The City of Portland, in cooperation with regional partners within the MSA (e.g., TriMet, Port of Portland, Multnomah, Clackamas, Washington and Columbia counties of Oregon and Clark County, Washington) of the Regional Disaster Preparedness Organization (RDPO), are applying for financial assistance to address the planning, training,

The Council declares that an emergency exists to meet grant submittal deadline on April 4, 2021 and any delay in application for this grant will result in losing the opportunity to apply for the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by Council.
