## 150168

An Ordinance increasing appropriation in the Parks Bureau by \$1,020,078 for implementation of an approved grant project from the Heritage Conservation and Recreation Service for rehabilitation of several parks; and declaring an emergency.

The City of Portland ordains:

## Section 1. The Council finds:

- 1. Ordinance No. 148390 passed by Council September 6, 1979 authorized application to the Heritage Conservation and Recreation Service (HCRS) of the Department of the Interior for a grant project totalling \$1,231,234 for park rehabilitation.
- 2. HCRS approved the application on March 28, 1980 as project No. 41 Cty 1650-79-01. The HCRS federal share is \$909,049. The required match is provided by the State of Oregon(\$47,185) and the City of Portland (\$175,000 from the General Fund and \$100,000 from HCD funds).
- 3. Of the \$1,231,234 project, \$8,936 is designated as indirect costs leaving \$1,222,298 to be expended by the Park Bureau. \$275,000 was appropriated in F.Y. 1979-80. \$162,220 was obligated. Hence, \$1,060,078 should be appropriated in F.Y. 1980-81 for completion of the project. \$40,000 of this amount was appropriated during the regular budget process, leaving \$1,020,078 to be appropriated by this ordinance.
- 4. The grant project, titled "Portland Parks Rehabilitation Project I" (UPARR I) is part of HCRS's Urban Park and Recreation Recovery Program authorized by Public Law 95-623 Title X. The grant will rehabilitate Essex, Farragut, McKenna, and Wallace Parks; redevelop Sunnyside School playground into a neighborhood park; and remove barriers to the physically handicapped at Columbia Park swimming pool and the Firehouse Theatre.
