

ORDINANCE NO. **150182**

An Ordinance authorizing the transfer of \$7,525 within the General Fund from the Bureau of Fire to Other Funds--Electronic Services Fund and increasing the appropriation of the Electronic Services Fund, Bureau of Electronic Services by \$7,525 for the purchase of video production equipment, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Council authorized a total of \$7,525 within the Bureau of Fire FY 1980-81 Budget for the purchase of a video tape recorder (\$3,450), an edit controller (\$1,425), a boom microphone (\$450), and a wave control(\$2,200).
- 2. That appropriations should more appropriately be transferred to the Bureau of Electronic Services for coordination and purchase of this video equipment.

NOW, THEREFORE, the Council directs:

- a. The FY 1980-81 City of Portland Budget is amended as follows:
