# ORDINANCE No. 15018

An Ordinance authorizing the City of Portland to waive certain street use fees required by Chapter 17.24 of the Code of the City of Portland relating to the City office building project on Block 57, Portland Addition, and declaring an emergency.

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City has entered into a lease-purchase agreement, Ordinance No. 149542, with the City of Portland, Oregon Public Buildings Corporation to provide a city office building on the Annex Block, Block 57, Portland Addition.
- The costs of the project will be paid for by the City through annual lease payments and such payments will include city permit fees.
- 3. The Council has waived the street use fees required by Chapter 24.44 of the Code of the City of Portland relating to the City office building on said block.
- 4. It is in the public interest to waive the street use fees for the city office building project, since such fees will result in an additional annual cost burden to the City.

### NOW, THEREFORE, the Council directs:

The street use permit fees as required by Chapter 17.24 of the Code of the City of Portland are waived for the city office building project that is being constructed on Block 57, Portland Addition, by City of Portland, Oregon Public Buildings Corporation.

### Section 2. The Council declares:

That an emergency exists in order that the project can continue without unnecessary expense and delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
