## ORDINANCE No. 150192

An Ordinance amending Section 4.28.010 of Chapter 4.28, Sick and Injury Leave of Title 4, Personnel, of the City Code in order to clarify the City's existing sick leave policy.

The City of Portland ordains:

Section 1. The Council finds:

- The City's current sick leave policy provides for payments to employees absent on account of personal sickness and/or injury.
- The determination of policy is required by Social Security regulations in conjunction with the exclusion of sick leave payments from Social Security taxes.
- Section 4.28.010 should be amended at this time to clearly show that payments are authorized on account of personal sickness or accident disability.

NOW, THEREFORE, the Council directs:

Section 4.28.010 of Chapter 4.28 Sick and Injury Leave, of Title 4, Personnel, of the Code of the City of Portland, is hereby amended /s to read as follows:

"'4.28.010% Absence on account of sickness. Payment of account of personal sickness or accident disability to any officer or employee is authorized in an amount equivalent to the time lost from scheduled duty. Exceptions to this policy are outlined in Section 4.28.090, or when such officer or employee is incapacitated to perform his duty because of the use of alcohol or any drug not prescribed by a licensed physician. However, sick leave with pay is authorized for time loss resulting from diagnosis and treatment by a licensed physician of an illness resulting from the misuse of alcohol or drugs."
