

ORDINANCE No. 150197

An Ordinance amending the City's current 1980-81 compensation plan for the classification of Purchasing Manager (Class No. 0424) in the Purchasing Division of the Bureau of Financial Affairs, effective July 1, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Personnel has completed a study of the compensation level of the City's Purchasing Manager position. Their survey indicates that the current single rate is not competitive beyond the entrance rate to the average maximum rates offered by other agencies and by private companies.
2. It is now recommended that new salary rates for this classification should be established effective July 1, 1980, to adequately compensate the Purchasing Manager position for the duties, responsibilities and scope of work performed by the position.
3. No additional appropriation is required in the Bureau of Financial Affairs to fund this position for the remainder of this fiscal year.

NOW, THEREFORE, the Council directs:

- a. New rates of pay as follows for the Purchasing Manager position (Class No. 0424) shall be adopted effective July 1, 1980, and the current Compensation Plan amended accordingly:

<u>Entry</u>	<u>1 Year</u>	<u>2 Year</u>
\$14.13/hr.	\$14.77/hr	\$15.43/hr.

Section 2. The Council declares that an emergency exists because delay would prevent the timely implementation of the new pay rates; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
