An Ordinance transferring appropriation in the amount of \$1,500 within the Mayor's Office budget to provide for replacement of office furniture, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The FY 80-81 budget for Facilities Management includes appropriation for remodeling the Mayor's Office.
- 2. Office furniture estimated at \$1,500 in the Mayor's Office foyer and conference room will need to be replaced as a result of the remodeling.
- The FY 80-81 furniture and equipment appropriation for the Mayor's Office is not sufficient to fund the required replacements.
- 4. Additional appropriation should be provided by transfer within the Mayor's Office budget from Materials and Services to Capital Outlay.

NOW, THEREFORE, the Council directs:

- a. Appropriation in the amount of \$1,500 is hereby transferred within the Mayor's Office (19500012) from Intra-fund services (580) to Furniture and Equipment (640).
- Section 2. The Council declares that an emergency exists, because the appropriation is needed immediately in the account to which it is to be transferred so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
