ORDINANCE NO.

150207

An Ordinance increasing resources and requirements in the Federal Grants and General Funds in the amount of \$1,965, for the purpose of appropriating grant funds to the Bureau of Economic Development for the continuation of CEDS administration activities under an Economic Development Administration grant award to the City of Portland; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 149852, the City of Portland accepted a grant amendment from the Economic Development Administration for funding of CEDS administration activities, in the amount of \$35,000.
- Of the total grant amendment award of \$35,000, expenditures during FY 1979-80 totalied \$31,328, leaving a balance of \$1,965, as shown below:
