An Ordinance increasing resources and requirements in the Federal Grants and General Funds in the amount of \$831, for the purpose of appropriating grant funds to the Bureau of Economic Development for the continuation of the 302(a) Economic Planning Program under an Economic Development Administration grant award to the City of Portland; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 147596, the City of Portland authorized a grant application to the Economic Development Administration for funding of Economic Development Planning Program. This grant was awarded the City by EDA in the amount of \$90,000.
- 2. Of the total award of \$90,000, expenditures during FY 1979-80 totalled \$32,269, leaving a balance of \$831, as shown below:
