

ORDINANCE No. 150221

An Ordinance transferring appropriation in the amount of \$5,000 within the General Fund from General Operating Contingency to the Office of the Mayor to provide funding for the Port Tour Educational Program, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance 149367, passed by Council April 9, 1980, authorized an agreement with the Multnomah County Education Service District to provide educational port tours for eighth grade students in Multnomah County during the 1980-81 school year and appropriated \$5,000 as the City's contribution to the program, contingent upon the Education District providing \$32,000 and raising another \$32,000 from other sources.
2. The \$5,000 appropriation in FY 79-80 could not be spent or encumbered by year end and should be reappropriated in FY 80-81 by a transfer from General Operating Contingency to the Office of the Mayor.


NOW, THEREFORE, the Council directs:

- a. Appropriation in the amount of \$5,000 is hereby transferred within the General Fund from General Operating Contingency (201) to the Office of the Mayor (19500012), Miscellaneous Services (260).

Section 2. The Council declares that an emergency exists, because the appropriation is needed immediately in the account to which it is to be transferred so that there may be no program interruption or administrative delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
