## Ordinance No.

## 150223

An Ordinance authorizing the transfer of \$14,750 within the General Fund from the Bureau of Police to Transfers to Other Funds - Electronic Services and increasing the appropriations of the Electronic Services Fund, Bureau of Electronic Services, by \$14,750 for the purchase of portable radio equipment and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the Bureau of Police recently reorganized its Juvenile Division to provide for a Community Juvenile Officer (C.J.O.) program.
- 2. That the C.J.O. program requires that each of the twelve (12) Officers assigned thereto, be equipped with a portable radio.
- 3. That the funds needed for the purchase of the said radios may be obtained by transfer of monies appropriated in the FY 80-81 budget for the Bureau of Police, Juvenile Division, for Electronic Services.
- 4. That the appropriations should be transferred to the Bureau of Electronic Services for the coordination and purchase of said radio equipment.

NOW, THEREFORE, the Council directs:

a. Appropriations of \$14,750 are hereby transferred with the General Fund as follows:


