## ORDINANCE No. 150225

An Ordinance creating one position of Human Resources Specialist II and abolishing one position of Human Resources Specialist III within the Training and Employment Division of the Human Resources Bureau, AU 682, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Training and Employment Division (TED) of the Human Resources Bureau requires the creation of one position and the elimination of one position within the Administration and Evaluation Section.
- 2. The Independent Monitoring Unit (IMU) requires the creation of one position of Project monitor, Human Resources Specialist II, (Job Class 7456).
- 3. One position within the Planning Unit, Human Resources Specialist III (Job Class 7456), is vacant and should be abolished.
- 4. This Ordinance will result in a savings of approximately \$5,000 to the TED FY 80-81 budget, which will be absorbed within the existing appropriations of the Bureau of Human Resources, TED.
- 5. The creation of this position will have no impact on the General Fund as funding for this position will come from the CETA Grant.

NOW, THEREFORE, the Council directs:

a. The following position is created in the Training and Employment Division of the Human Resources Bureau, AU 682, at salary rates in accordance with the current compensation plan of the City of Portland.

Project Monitor, Human Resources Specialist II (7456)

b. The following position in the Training and Employment Division of the Bureau of Human Resources is abolished.

Planner, Human Resources Specialist III (7457)

Section 2. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in unnecessary problems in the administration of the CETA programs; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
