

SUPPLEMENT TO AGREEMENT TO FURNISH
PROFESSIONAL SERVICES

RECITALS:

1. On November 12, 1976, the City of Portland (Owner) entered into an agreement with CH2M HILL, Inc. (Engineer), entitled "Agreement to Furnish Professional Services to the City of Portland, Oregon, by CH2M HILL, Inc., Portland, Oregon, for Bull Run Hydroelectric Power Development" (Services Agreement).

2. Article 2, paragraph 4, of the Services Agreement sets as the fee for Task 4 inspection services provided by the Engineer "the amount of the ENGINEER'S Salary Costs, as defined in ARTICLE 4, expended for the services, multiplied by a factor of 2.0 plus direct expenses in connection therewith".

3. The Engineer and the Owner mutually desire to modify the consideration for providing Task 4 inspection services as set forth below.

AGREEMENT:

1. The Engineer will provide the Task 4 inspection services at the level and for the consideration set forth in the mutually agreed schedule of services, entitled "Portland Hydroelectric Project Task 4 Budget Forecast", dated July 15, 1980, not to exceed \$880,273.

2. Task 4 inspection services beyond those specified in the Portland Hydroelectric Project Task 4 Budget Forecast shall be performed only upon the written authorization of the Owner, and if authorized shall be compensated pursuant to the terms of Article 2, paragraph 4, of the Services Agreement.

3. For the first \$82,457 of direct expenses incurred by the Engineer in connection with Task 4 inspection services, the Owner shall compensate the Engineer for an amount up to \$54,457. For expenses greater than \$54,457 but less than \$82,457, the Owner will receive a full credit up to \$28,000. Additional expenses shall be incurred over the amount of

\$82,457 only upon the written authorization of the Owner, and if authorized shall be compensated by Owner pursuant to the terms of Article 2, paragraph 4, of the Services Agreement.

An Ordinance authorizing the Commissioner of Public Utilities and the Auditor to enter into an Agreement with CH2M-Hill, Inc., supplementing an earlier Agreement, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The City Council, by Ordinance No. 142699, authorized the Mayor and the Commissioner of Public Utilities to enter into an Agreement with CH2M-Hill, Inc. (Engineer), for professional services related to the Portland Hydroelectric Project. Said Agreement was entered into on November 12, 1976.
2. Article 2, paragraph 4, of said Agreement sets as the fee for Task 4 inspection services provided by the Engineer "the amount of the ENGINEER'S Salary Costs, as defined in ARTICLE 4, expended for the services, multiplied by a factor of 2.0 plus direct expenses in connection therewith".
3. The Engineer's original estimate as to the extent of Task 4 inspection services necessary is well below the actual level of inspection services that are necessary, resulting in substantially higher costs to the City.
4. The City and the Engineer desire to reduce said costs by modifying the consideration for providing Task 4 inspection services by limiting the number of inspection personnel whose services would be paid for pursuant to the multiplier clause of Article 2, paragraph 4 of the Agreement, and by limiting the amount of expenses chargeable to the City.
5. There is attached hereto, and made a part of this Ordinance as Exhibit "A", a Supplement to said Agreement which accomplishes the objectives stated above, and which the Council should authorize the Commissioner of Public Utilities and the Auditor to enter into.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Utilities and the Auditor are hereby authorized to execute the Supplement to the original November 12, 1976 Agreement between the City and CH2M-Hill, Inc., attached as Exhibit "A" to this Ordinance.
