Purpose of proposed legislation and background information:

• Accept grant from PGE Drive Change Fund in the amount of \$130,000 to provide BIKETOWN for All ride credit

Financial and budgetary impacts:

 - The proposed project will cost \$130,000. PBOT has an existing BIKETOWN program with staff and program costs for the BIKETOWN for All portion covered by a combination of General Transportation Revenues and sponsorship revenues. The proposed program would enhance the benefit of the BIKETOWN for All program by providing free BIKETOWN ride credit. This additional benefit is fully covered by the grant.

This would provide each BIKETOWN for All participant approximately 50 free rides.

 The \$130,000 will be assigned to PBOT's FY 21-22 budget.
