## **ORDINANCE NO. 190419**

\*Amend contract with SAP Public Services, Inc. to increase the not to exceed value by \$293,000 for software cloud services through June 2022 (Ordinance; amend Contract No. 30005306)

The City of Portland ordains:

Section 1. The Council finds:

- In 2016, the City entered into Contract No. 30005306 with SAP Public Services, Inc. for Cloud Services for the City's Enterprise Business System (EBS). The contract with SAP provided for comprehensive, integrated cloud services and supports essential citywide Human Resource business functions such as the Learning Management System, Onboarding, and Performance and Goals Management. Included in this contract are Learning Hub subscriptions to support SAP online training for the Bureau of Technology Services, Enterprise Business Solutions team.
- 2. Contract No. 30005306 will reach the end of its initial term on June 30, 2021 and will be renewed for one year through June 30, 2022.
- This ordinance authorizes adding funding to Contract No. 30005306 in the amount of \$293,000 for a new total not-to-exceed value of \$1,444,810.70 to fund the subscription charges outlined below through June 30, 2022 to support the City's SAP Cloud Services.
