## ORDINANCE NO. 150843

An Ordinance creating one position of Commissioner's Assistant II in the Office of the Commissioner of Public Works and one position of Commissioner's Assistant III in the Office of the Commissioner of Public Affairs, effective December 11, 1980, transferring appropriation, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Both the Offices of the Commissioner of Public Works and Commissioner of Public Affairs have a marked increase in workload due to recent bureau reassignments.
- 2. That each Office requires an additional Commissioner's Assistant to meet the increased administrative responsibilities and to aid in transition of some of these responsibilities to the new Commissioner of Public Utilities.
- 3. In order to provide funds for these positions, it will be necessary to transfer appropriation from the Office of the Commissioner of Public Utilities to the Offices of the Commissioners of Public Works and Public Affairs.
- 4. That due to savings realized by the vacant Office of the Commissioner of Public Utilities, this action will not impact the city budget.

NOW, THEREFORE, the Council directs:
