Here is a transcript of my public testimony. I would also like to "screen share" the second page of names while giving my communication.

It's so wonderful to see Police Commissioner Ted Wheeler again, the police commissioner overseeing the bureau with the highest increase in police brutality incidents across the nation over the last 4 years. It's great to see him tweeting about the horrific ramifications of police brutality. Unfortunately, his contributions don't end with hollow lip service. He claims all violence is unacceptable, yet he continues to employ known White Supremacists from out of town so they can suit up in PPB gear and gas peaceful members of our community. When you wake up in the morning and look in the mirror, do you see the faces of the people murdered by your officers during your tenure? Or, since you received less than 47% of the vote, do you not consider them 'your' constituents? Is that why you only take meeting requests from the PDX business Alliance?

Hundreds of my neighbors now walk the street with very real and deep pain from the brutality of four years of your PPB oversight. Under your leadership we have seen: kneecaps, skulls, and faces shattered by police batons; arms and legs fractured by Teargas canisters; seizures induced by weaponized strobing flashlights; dozens of women who now have extremely painful and irregular menstrual cycles and people with new cases of asthma from your lax deployment of Teargas; We have seen cops routinely dogpile on a single peaceful BIPOC protester. We have been forced to watch in horror as cops repeatedly mace a handcuffed citizen while they are lying on their stomachs, gurgling out screams of pain. This physical and emotional trauma is the only real contribution you have managed to provide during your term. I encourage anyone listening to reach out to TotalRecallPDX and any other organization that is working to recall Commissioner Ryan and Police Commissioner Wheeler for their repeated egregious failures.
