## ORDINANCE NO. 150858

An Ordinance renewing four park concessionaire contracts for a period of two years commencing January 1, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That four present contracts with park concessionaires expire December 31, 1980.
2. The City Code, §5.32.070 provides that such concession contracts may be once renewed for a term equal to the original term if requested by the concessionaire and approved by the Commissioner in Charge.
3. That the concessionaires as listed below have requested renewal of their contracts for a two year period commencing January 1, 1981 upon the same terms and conditions as the original contract. That such request has been approved by the Bureau of Parks and the Commissioner in Charge.

NOW, THEREFORE, the Council directs:

- a. That the following listed concession contracts are hereby extended for a period of two years commencing January 1, 1981 upon the same terms and conditions as the original agreement:
