ORDINANCE NO. 150860

An Ordinance amending Ordinance No. 150367, passed by the Council on September 10, 1980, which changed the zoning for a portion of Tax Lot 3 and part of Tax Lot 221, Section 21, T1S, R1E, at S.W. Vermont and 24th, from A2.5 to C5, under certain conditions and declared an emergency, so as to correct the legal description contained in Ordinance No. 150367, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Council, on September 10, 1980, adopted Ordinance No. 150367, which changed the zone on a portion of Tax Lot 3 and part of Tax Lot 221, Section 21, TIS, RIE, at S.W. Vermont and 24th, from A2.5 to C5.
- 2. The specific legal description furnished by the applicant, and contained in paragraph 3 of Section 1 of Ordinance No. 150367, is incorrect.
- 3. The legal description in paragraph 3 of Section 1 of Ordinance No. 150367 should read as follows:

"A tract of land situated in the northwest one-quarter of Section 21, T1S, R1E, W.M., Multnomah County, Oregon, being described as follows;

Beginning at the Northwest corner of said Section 21; thence EAST along the north line of said Section 21 a distance of 430.00 ft.; thence S 0° 14' E parallel with the west line of said Section 21 a distance of 30.00 ft. to a point in the south R/W line of S.W. Vermont Street and the true point of beginning of the tract herein to be described; thence S 0° 14' E parallel with the west line of said Section 21 a distance of 235.00 ft.; thence EAST a distance of 13.00 ft.; thence N 20° 17' E a distance of 27.50 ft.; thence N 63° 04' 40" E a distance of 86.59 ft.; thence N 0° 14' W a distance of 170.00 ft. to a point in the south R/W line of S.W. Vermont St.; thence WEST along said south R/W line a distance of 100.00 ft. to the true point of beginning."

4. The substitution of the correct legal description in place of the incorrect legal description will facilitate the reasonable use of this property.

NOW, THEREFORE, the Council directs:

a. That Ordinance No. 150367 is amended by substituting the legal description found in paragraph 3 above for that found in paragraph 3 of Ordinance No. 150367.
