## ORDINANCE NO. 150867

An Ordinance authorizing an amendment to Ordinance No. 150499; authorizing wage adjustments for four (4) Public Service Employment, Title VI, positions within the Bureau of Planning; authorizing increases in salary and fringe categories and expenditures within the CETA Fund of \$988 retroactive to October 13, 1980 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland has been designated by the U. S. Department of Labor as Prime Sponsor for administering funds under the Comprehensive Employment and Training Act (CETA) to provide employment to the economically disadvantaged.
- 2. Pursuant to Ordinance No. 150499, Council authorized the creation of four (4) CETA Title VI Special Project positions within the Bureau of Planning.
- 3. Due to changes in the City's Compensation Plan, salaries indicated for those positions were calculated incorrectly and adjustments are necessary to correct the error.
- 4. Funds have been budgeted and are available for FY 80-81 under CETA Title VI from the Department of Labor.
- 5. The costs, originally budgeted and the revisions, are set out in Exhibit "A" hereof.
- ö. It is therefore appropriate that an amendment to Ordinance No. 150499 be authorized, increasing salary and fringe amounts retroactive to October 13, 1980 as set forth in Exhibit "A" attached.

NOW, THEREFORE, the Council directs:

a. That an amendment to Ordinance No. 150499 be authorized, increasing salary and fringe amounts retroactive to October 13, 1980 as set forth in the exhibits hereof.
