AMENDMENT NO. 3 TO
CONTRACT NO. 30006755
FOR
EMERGENCY MEDICAL TRIAGE SOFTWARE**

This Amendment No. 3 amends Contract No. 30006755 dated 1st day of August, 2019, by and between Medical Priority Consultants, Inc. d/b/a Priority Dispatch Corp. ("Contractor" or "PDC") a Utah corporation, and the City of Portland, a municipal corporation of the State of Oregon ("City") by and through their duly authorized representatives. This Amendment may refer to Contractor and City individually as a "Party" or collectively as the "Parties."

The Effective Date of this Amendment is May 1, 2021. The purpose of this Amendment is to extend the Term, add funds, revise Exhibit A, Contractor's Price, and incorporate Exhibit A.1, Contractor's Quote No. Q-47581. For the purpose of this Amendment, deleted language appears in ~~strike through~~, and new language appears in **bold and underline**.

The Contract was previously amended as follows:

- Amendment No. 1 dated April 1, 2020 extended the Term from July 31, 2020 to July 31, 2021.
- Amendment No. 2 dated May 1, 2020, increased the Contract not-to-exceed amount by adding \$70,570.00, for a new total not-to-exceed amount of \$880,417.00.

The Parties agree to amend the Contract as follows:

1. The Term of the Contract is extended from July 31, 2021 to July 31, 2025.
2. The not-to-exceed amount of the Contract is increased by the amount of **\$1,492,331**, for a revised total not-to-exceed amount of **\$2,372,748**.
3. Exhibit A.1, Contractor's Quote No. Q-47581 is hereby incorporated into Exhibit A, Contractor's Price.
4. Exhibit A, Contractor's Pricing shall be revised as follows:
 - A. The quantities of the following line items shall be increased as indicated below:
 - i. Page 35 Line 17 "Protocol Training and Certification for EMD/EFD/EPD" is increased from a quantity of 140 **by an additional 40, for a revised quantity of 180** to account for expected new employee hires and training during the four (4) year extension (associated cost: \$40,800).

- ii. Page 35 Line 18 "ED-Q Training for EMD/EFD" is increased from a quantity of 8 **by an additional 8 for a revised quantity of 16**, for additional quality assurance training (associated cost: \$8,800).
- iii. Page 37 Line 1 "ProQA Police Software Licenses" is increased from a quantity of 30 **by an additional 6 for a revised quantity of 36**, to match medical and fire software licenses (associated cost: \$22,500).
- iv. Page 37 Line 3 "Protocol Tablet for EPD" is increased from a quantity of 30 **by an additional 6 for a revised quantity of 36**, to match medical and fire tablet licenses (associated cost: \$,2370).

B. The following item is added to Exhibit A, Contractor's Price:

- i. Dispatcher/Supervisor two (2) year recertification for medical, fire, and police protocols (associated cost \$23,100).

All other terms and conditions of the Contract remain unchanged by this Amendment and in full force and effect.
