Section 1. The Council finds:

The Bureau of Personnel Services has performed a classification review for the new training specialist position in the Bureau of Maintenance and has recommended the classification be established as Training & Development Officer, Class Code 0650, at a salary of \$10.66/hr entry and \$11.22/hr after one year.

The Civil Service Board created the classification of Training & Development Officer at its November 18, 1980 meeting.

## NOW, THEREFORE, the Council directs:

One position of Training Specialist is abolished; and

One position of Training and Development Officer is created in the Bureau of Maintenance.

The hourly rate for the classification, Training and Development Officer, Class Code 0650, is established in the Compensation Plan as a rate of \$10.66 per hour entrance and \$11.22 per hour after one year of service.

Section 2. The Council declares that an emergency exists because the position being created is required immediately in order that the functions of the Bureau of Maintenance may be carried out without delay; therefore, this Ordinance should be in force and effect from and after its passage by the Council.
