## ORDINANCE No. 150877

An Ordinance amending Chapters 20.30 and 20.48 of the City Code relating to rates charged at Portland Indoor Tennis Center and St. Johns Racquet Center, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Parks operates the Portland Tennis Center and St. Johns Racquet Center as self-sustaining facilities within a separate enterprise fund.
- 2. Fee structures at both centers are designed to generate revenues sufficient to pay operating expenditures and bond redemption requirements as applicable.
- 3. Increased use of the facilities should be encouraged by establishing fees for group use of the centers.
- 4. Chapters 20.30 and 20.48 of the City Code should be amended to reflect this adjustment effective January 1, 1981.

NOW THEREFORE, the Council directs:

Chapter 20.30 and 20.48 of the Code of the City of Portland is hereby amended by adding as follows:

- A. 20.30.010 Playing rates: (insertion letter (e))
- (e) The following rate shall be charged for Adult Indoor Tennis league play during the months of October through May: \$125 per team per session of seven matches.
- B. 20.48.010 Playing rates: (insertion letter (j))
- (j) The following rate shall be charged for Adult Indoor Tennis league play during the months of October through May: \$125 per team per session of seven matches.
