ORDINANCE 150879

An Ordinance authorizing the conveyance at no cost to Multnomah County of a 40-foot-wide strip of land containing 0.93 acres by a deed for road purposes and a one-foot-wide strip of land containing 40 square feet, by a bargain and sale deed for a non-access reservation site in the Groundwater Development Program of the Bureau of Water Works, and declaring an emergency.

The City Of Portland ordains:

Section 1. The Council finds:

- 1. Part of the requirements of Multnomah County for the land division necessary to develop the pump station site for the Groundwater Development Program of the Bureau of Water Works is that the City transfer to Multnomah County a 40-foot-wide strip of land containing 0.93 acres as a road dedication and a one-foot-wide strip of land containing 40 square feet for a non-access reservation.
- 2. Ordinance No. 148862 authorized an agreement between the City of Portland and Mabel M. Venema, the previous owner of the pump station site, in which the City agreed to make said 40-foot-wide road dedication and Mabel M. Venema agreed to make other road dedications necessary to provide access to the pump station site.
- 3. Multnomah County requires said one-foot-wide non-access reservation to control development of the land east of said pump station site.
- 4. Copies of the deed for road purposes and the bargain and sale deed are attached to the original only hereof, marked Supplements No. 1 and No. 2, respectively, and by this reference made a part hereof.
- 5. The conveyance of these two parcels to Multnomah County at no cost was recommended by the Administrator of the Bureau of Water Works, and approved by the Commissioner-in-Charge.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor hereby are authorized to convey at no cost the land by deed for road purposes and the land by bargain and sale deed, as described in said Supplements No. 1 and 2, respectively.
- Section 2. The Council declares that an emergency exists because a delay in the conveyance of these two parcels may result in additional expense
