ORDINANCE NO. 151043

An Ordinance creating a Special Appropriation-Oregon Historical Society within the General Fund, transferring appropriation of \$15,000 from General Operating Contingency to said Special Appropriation, authorizing the drawing and delivery of a warrant, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Oregon Historical Society provides valuable archival, educational, research and consultant services to Portland citizens, students, business and community organizations and to City Government.
2. The Oregon Historical Society preserves and maintains important historical documents of the City, provides archival services to preserve historical and cultural artifacts, and assists City bureaus in historical research for City programs and administrations.
3. The Oregon Historical Society has requested funding from the City to continue its program in FY 80-81.
4. The City has provided funding and support of the Oregon Historical Society in prior years in recognition of this valuable service to the community and the City. However, no appropriation was provided in the FY 80-81 approved budget.

NOW, THEREFORE, the Council directs:

- a. A Special Appropriation-Oregon Historical Society is hereby created within the General Fund for FY 80-81.
- b. The FY 80-81 budget is hereby amended by transfer of appropriation of \$15,000 from General Operating Contingency to the Special Appropriation-Oregon Historical Society.
- c. The Mayor and Auditor are hereby authorized to draw and deliver a warrant chargeable to the aforementioned Special Appropriation when demand is presented and approved by the proper authorities.
