

ORDINANCE No. 150888

An Ordinance creating one position of Building Plan Examiner II (3221) and abolishing one position of Building Inspector I (2140) in the Bureau of Buildings, AU 520; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. In order to provide for proper Civil Service classification of an employee, one position of Building Inspector I should be abolished and one position of Building Plan Examiner II should be created.
2. The additional cost is \$250.56, which is available in the bureau's budget due to employee turnover.
3. The Bureau of Personnel has reviewed and concurs in the recommended title change.

NOW, THEREFORE, the Council directs:

1. One position of Building Inspector I is abolished and one position of Building Plans Examiner II is created in the Bureau of Buildings.

Section 2. The Council declares that an emergency exists because the position change needs to be made to comply with Civil Service classifications; therefore, this Ordinance shall be in effect from and after its passage by the Council.
