

ORDINANCE NO. 151015

An Ordinance authorizing application to the Department of Housing and Urban Development for an Urban Development Action Grant under Title I of the Housing and Community Development Act of 1974, as amended, in the amount of \$265,000 for industrial expansion of Graphic Arts Center, Inc., authorizing contracts, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Title I of the Housing and Community Development Act of 1974, as amended, provides that the Secretary of Housing and Urban Development may make Urban Development Action Grants to eligible cities upon submission of an acceptable application.
2. The City of Portland has been determined by the Department of Housing and Urban Development to be an eligible applicant.
3. The City of Portland has authorized, by Ordinance No. 149001, as amended by Ordinance No. 150813, identification of potential UDAG projects by the City's Action Grant Program.
4. The Action Grant Program has received a request for UDAG assistance in connection with the industrial expansion of Graphic Arts Center Inc.
5. The Action Grant Program staff has prepared a staff report and favorable recommendation.
6. It is appropriate and in the public interest that the Mayor be authorized to apply for and receive UDAG funds.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to apply for and receive from the Department of Housing and Urban Development an Urban Development Action Grant in the amount of \$265,000.
- b. The Mayor is authorized to provide such assurances and information to the Department of Housing and Urban Development as may be required for the application and orderly management of the grant.
- c. Should the Described Grant be approved, a contract or grant agreement with the Department of Housing and Urban Development is authorized to be signed by the Mayor, along with such participating party agreements and may be required by such grant agreement or contract.

Section 2. The Council declares that an emergency exists so that the grant funds, as described in Section 1 hereof, may be available without undue delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
