# ORDINANCE No. 150891

An Ordinance authorizing the use of Eastmoreland Golf Course for qualifying rounds for the 1981 Women's Amateur Public Links Championship golf tournament on June 5, 1981, without payment of greens fees, notwithstanding provisions of Section 20.20.010 of the City Code, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. The United States Golf Association has requested use of Eastmoreland Golf Course for the qualifying rounds for the 1981 Women's Amateur Public Links Championship golf tournament on June 5, 1981, without payment of greens fees.
- 2. The exposure resulting from this tournament would be beneficial to the City's public golf program which would be in the best interest of the public and therefore, such use has been approved by the Commissioner in charge of the Bureau of Parks.

NOW, THEREFORE, the Council directs:

- a. Use of Eastmoreland Golf Course is authorized for the qualifying round for the 1981 Women's Amateur Public Links Championship golf tournament on June 5, 1981, without payment of greens fees, notwithstanding provisions of Section 20.20.101 of the City Code.
- Section 2. The Council declares that an emergency exists because delay in enactment of this ordinance would cause unnecessary difficulty in making arrangements for the tournament; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
