An Ordinance amending Ordinance No. 148714, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended July 31, 1979, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 148714 assessed James Johns 2nd Add., Block 18, Lot 5 & 6, \$176.40 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended July 31, 1979, and entered in the City Lien Docket Book 124, Page 92.
- 2. The present owner was not the deedholder of the subject property at the time of the nuisance abatement.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 148714 is amended by reducing the assessment against James John 2nd Add., Block 18, Lots 5 & 6, by \$88.40 and reducing the total assessment of \$4,705.80 to \$4,617.40.
- Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
