The City of Portland ordains:

#### Section 1. The Council finds:

- 1. On July 9, 1980, Ordinance No. 149997 was passed declaring the Service Station site at 4830 S.E. Belmont Street, more particularly described as Lots 1-3 and 6-8, Block 10, PARADISE SPRINGS TRACT in the City of Portland, Multnomah County, Oregon to be a nuisance and providing abatement by removal.
- 2. On September 16, 1980, Conditional Use 70-80 was granted to reopen a service station which has not been operated since 1978. This, in essence, will provide for the abatement of the nuisance.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 149997 is repealed in its entirety.

Section 2. The Council declares:

That an emergency exists because delay in the enactment of this ordinance could result in unnecessary action by the Director of the Bureau of Buildings in abatement of the nuisance. Therefore, this ordinance shall be in force and effect, from and after its passage by Council.
