

ORDINANCE No. 150900

An Ordinance amending Ordinance No. 148812, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 148812 assessed Lot 11, Block 12, Albina Homestead \$516.60 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1980, and entered in the City Lien Docket Book 124, Page 112.
2. On December 17, 1980, Council Calendar No. 4416, the assessment was reduced by Council action to \$60.00.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 148812 is amended by reducing the assessment against Lot 11, Block 12, Albina Homestead, by \$456.60 and reducing the total assessment of \$12,591.38 to \$12,134.78.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
