ORDINANCE NO. 151057

An Ordinance amending Section 5.52.010 of the City Code to abolish the petty cash accounts for the Bureau Economic Development, the Office of Planning and Development, and the Neighborhood Programming Section; creating petty cash accounts for the Energy Office, Office of Emergency Services, Housing and Community Development, and the Economic Planning Section; authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. By Ordinance 150813 the Office of Planning and Development and the Bureau of Economic Development were abolished.
- 2. By this same ordinance, the Economic Planning Section in HCD was created and the Office of Emergency Services became a separate AU.
- 3. Abolition of the Office of Planning and Development eliminated petty cash appropriations for the Energy Office and Housing and Community Development.
- 4. Therefore, new petty cash accounts for the Energy Office, Office of Emergency Services, Housing and Community Development, and the Economic Planning Section need to be established.

NOW, THEREFORE, the Council directs:

a. Section 5.52.010 of the City Code is amended to abolish the petty cash accounts for the Bureau of Economic Development, the Office of Planning and Development, and the Neighborhood Programming Section, and to create petty cash accounts for the following:

The Mayor and the Auditor are hereby authorized and directed to draw and deliver a warrant chargeable to Special Appropriations-Petty Cash Increases (43813498/.490) in the amount of \$50 each and payable to the Energy Office and the Office of Emergency Services.

The Mayor and the Auditor are hereby authorized and directed to draw and deliver warrants chargeable to the Housing and Community Development Fund (53200010/.490) and (53800106/.490) in the amount of \$50 each and payable to Housing and Community Development and the Economic Planning Section, HCD II.

Section 2. The Council declares that an emergency exists in order that the enactment of this Ordinance and Code change may be made without unnecessary delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
