## ORDINANCE No. 151059

An Ordinance increasing resources and requirements in the Federal Grants Fund and the General Fund, Bureau of Parks for planting of street trees on Union Avenue and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The City of Portland entered into agreement 18069 with the State of Oregon, Department of Transportation, Highway Division for the improvement of Union Avenue by Ordinance 148061.
- 2. As part of that agreement, the Bureau of Parks, Street/Park Tree Division will plant trees on the improved areas of Union Avenue.
- 3. The Bureau of Parks will be reimbursed by the State of Oregon for expenditures incurred in planting trees on the improved areas of Union Avenue.
- 4. The Bureau of Parks requires additional appropriation in the amount of \$42,000 for the purchase and planting of street trees on Union Avenue.

#### NOW THEREFORE, the Council directs:

a. The 1980-81 resources and requirements of the Federal Grants Fund and the General Fund, Bureau of Parks are increased as follows:
