ORDINANCE No. 150904

An Ordinance abolishing two positions of Human Resources Specialist III (7457) and creating one position of Human Resources Specialist IV (7458) within the Human Resources Bureau's Training and Employment Division, AU 682, and declaring an emergency.

TOTETTO!

The City of Portland ordains:

Section 1. The Council finds:

- 1. Two positions of Human Resources Specialist III are currently vacant.
- 2. The Training and Employment Division is in need of a Human Resources Specialist IV to supervise and coordinate the Targeted Jobs Demonstration Program, Private Industry Council programs and related private sector programs, thus combining the functions formerly performed by the two Human Resources Specialist III positions.
- 3: That these personnel actions have been reviewed and approved by the Bureau of Personnel Services.
- That the abolishment and creation of positions will result in a savings of \$11.016 to the CETA Fund.
- 5. There is no impact on the General Fund.
- 6. It is therefore appropriate that two positions of Human Resources Specialist III (7457) be abolished and a position of Human Resources Specialist IV (7458) be created within the Training and Employment Division.

NOW, THEREFORE, the Council directs:

Pro-S

That two positions of Human Resources Specialist III (7457) be abolished and one position of Human Resources Specialist IV (7458) be created within the Human Resources Bureau, Training and Employment Division, AU 682, at a salary rate in accordance with the current compensation plan of the City of Portland.

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance will result in unnecessary problems in the administration of the CETA program; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
