An Ordinance reclassifying one Human Resources Specialist II to Human Resources Specialist III within the Human Resources Bureau, AU 682, Training and Employment Division, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Training and Employment Division (TED) of the Human Resources Bureau has determined that one position of Human Resources Specialist II (Job Class 7456) within the Youth Career Training Unit should be reclassified to Human Resources Specialist III (Job Class 7457).
- This reclassification is necessary due to an increase in duties and responsibility to the level of other Human Resources Specialist III positions within the Youth Career Training Unit.
- The reclassification has been reviewed and approved by Civil Service.
- This Ordinance will result in a cost of approximately \$1,430 to the TED FY 1980-81 budget, which will be absorbed within the existing appropriations of the Bureau of Human Resources, AU 682, Training and Employment Division.

Human Resources Specialist II (7456) to Human Resources Specialist III (7457)

Section 2. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in unnecessary problems in the administration of the CETA programs; therefore, this Ordinance shall be in force and effect from and after its passage by Council,
