An Ordinance accepting two sewer easements right of way for the Private Property North of SW Dosch Road and Boundary Street Storm and Sanitary Sewer Project, granted by James G. Driscoll and Patricia Anne Driscoll, and Century 21 Homes, Inc., and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Right of way is required for construction of the Private Property North of SW Dosch Road and Boundary Street Storm and Sanitary Sewer Project.
- James G. Driscoll and Patricia Anne Driscoll, and Century 21 Homes, Inc. have conveyed the required right of way to the City at no cost to the City.

NOW, THEREFORE, the Council directs:

a. That the following described easement is hereby accepted for sewer purposes:

PARCEL I - A strip of land in Dosch Estates in Section 17, T1S, R1E, W.M., Multnomah County, Oregon being 15.0 feet in width, 7.50 feet on each side of the following described centerline:

PARCEL II - A strip of land in Dosch Estates in Section 17, T1S, R1E, W.M., Multnomah County, Oregon being 15.0 feet in width, 7.50 feet on each side of the following described centerline:

PARCEL III - A strip of land in Dosch Estates in Section 17, TIS, RIE, W.M., Multnomah County, Oregon being 20.0 feet in width, 10.0 feet on each side of the following described centerline:

Beginning at a point which is the most southerly corner of Lot 19, Dosch Estates; thence S.11°41'25"W. 10.90 feet to the beginning of the centerline to be described; thence N.78°13'59"E. 111.00 feet to the end point of the 15.00 foot sanitary sewer easement, which lies N.07°49'34"E. 10.62 feet from a point which is the most northerly corner of Lot 22, Dosch Estates.

PARCEL IV - That portion of Lot 12, Dosch Estates, Multnomah County, Oregon, lying southeasterly of the above described 15.0 foot wide easement designated as Parcel II.

PARCEL V - A strip of land in Dosch Estates in Section 17, T1S, R1E, W.M., Multnomah County, Oregon being 15.0 feet in width, 7.50 feet on each side of the following described centerline:

(Granted by James G. Driscoll and Patricia Anne Driscoll, and Century 21 Homes, Inc., 7412 SW Beaverton-Hillsdale Hwy., Portland, Oregon 97225; ATTN: Mr. Herb Book).

b. The Auditor shall record in the appropriate deed records, documents of title as necessary for acquisition of this right of way.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the sewer easements might result in delays in construction of the sewer; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
