ORDINANCE NO. 151074

An Ordinance extending a Contract with Beehive Medical Computer Systems, Inc., to provide CRT Terminal maintenance service to the Bureau of Electronic Services for assignment to the Bureau of Emergency Communications, in the estimated amount of \$13,353, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Beehive Medical Computer Systems, Inc., provided CRT Terminals to the City of Portland through a Contract with the lowest responsible bidder;
- 2. Beehive Medical Computer Systems, Inc., 870 West 2600 South, Box 19244, Salt Lake City, Utah 84120, has the necessary technical skill, experience, and capacity to provide maintenance service on the terminals;
- 3. Beehive Medical Computer Systems provided maintenance on the CRT Terminals during 1977-78, 1978-79 and 1979-80 through Contract Number 16101;
- 4. Funds for the twelve-month extension are available in the 1980-81 Budget of the Bureau of Electronic Services;
- 5. Extension of the Contract with Beehive Medical Computer Systems, Inc., to provide CRT Terminal maintenance service has been recommended and approved by the Commissioner-in-Charge.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall sign a Purchase Order extending a contract with the company named in Section 1., for CRT Terminal maintenance service through June 30, 1981, in the amount of \$13,353, without advertising for bids. The Purchase Order shall be approved as to form by the City Attorney.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants chargeable to the 1980-81 Budget; Bureau of Electronic Services, Electronic Services Operating Fund, (36900041.240), for services from July 1, 1980 through June 30, 1981 in the estimated amount of \$13,353, when demand is presented, approved by the proper authorities.

ORDINANCE No.

Section 2. The Council declares that an emergency exists because a delay in proceeding may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the Contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
