

ORDINANCE NO. **150920**

An Ordinance creating one (1) position of Handicap Program Coordinator and abolishing one (1) position of Assistant Management Analyst in the Metropolitan Human Relations Commission, RU 341, effective July 1, 1980, establishing salary rates for the Compensation Plan, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. One (1) position of Handicap Program Coordinator is required by the Metropolitan Human Relations Commission, RU 341.
- 2. This position is needed to properly identify and compensate the position responsible for coordinating and administering the Handicap Assistance Program within the Metropolitan Human Relations Commission.
- 3. One (1) position of Assistant Management Analyst can be abolished to provide the appropriation for the position being created.
- 4. The change and salary rates have been approved by the Bureau of Personnel Services.

NOW, THEREFORE, The Council directs:
