

Director's Update - July 2021

Upcoming Council Items

- July 28:

General Updates

- Metro Bond:
 - Spring 2021 solicitation for \$80.5M in Metro Bond funds, Central Eastside Tax Increment Financing, and Joint Office of Homeless Services operational funding closed July 2.
 - Twenty-four applications under review, including proposals for PHB's 5020 N. Interstate site and a Metro-owned site at 432 NE 74th.
- Portland Housing Bond (see also progress report attachment):
 - Seven projects have started construction activities: Crescent Court, Cathedral Village, Hayu Tilixam, Las Adelitas, the Westwind, Stark Street Housing, and Emmons Place.
 - Three projects (3000 SE Powell, Anna Mann House, and Joyce Hotel) are on track to close and begin construction by the end of 2021.
- COVID-19 Rent Assistance:
 - PHB, JOHS, DCHS and Home Forward have implemented a 2021 Community Rent Assistance Program in April. The program intention is to have funds continue to be dispersed seamlessly to community but will flow in multiple phases.
 - Consortium 2021 phase 1: \$14.4 million (STARR, CDBG, city funds)
 - Consortium 2021 phase 2: \$24.4 million (ERAP local funds "ERAP-1")
 - Consortium 2021 phase 3: \$30 million (ARPA rent assistance estimate)
 - The ERAP-1 program launched last week, with an official program start date of July 1, 2021. Funds
 are prioritized to be spent by February 2022; however, funds can be spent through the end of the
 fiscal year, June 30, 2022. Details on partner agencies and program guidelines:
