

ORDINANCE NO. 151078

An Ordinance repealing Ordinance No. 143765 which granted a revocable permit to Anthony Silvers to use in connection with operating the Chocolate Moose Restaurant a portion of the sidewalk area of S.W. 2nd Avenue adjacent to 211 S.W. Ankeny Street for a sidewalk cafe, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Anthony Silvers, dba Chocolate Moose Restaurant, requested permission to use a portion of the sidewalk area fronting the restaurant for sidewalk cafe purposes.
2. By Ordinance No. 143765 a revocable permit was granted to Anthony Silvers for the purpose requested under certain conditions.
3. December 11, 1980 Anthony Silvers, dba Chocolate Moose Restaurant, was notified by registered mail that he had fifteen days from the date of receipt of the notification to either comply with the conditions of Ordinance No. 143765 or remove the materials he had placed in the sidewalk area.
4. The registered letter referred to above was receipted for December 30, 1980 and no action was initiated or taken on or before January 14, 1981 by the permittee to comply with the conditions of Ordinance No. 143765.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 143765 entitled "An Ordinance granting a revocable permit to Anthony Silvers to use in connection with operating the Chocolate Moose Restaurant a portion of the sidewalk area of S.W. 2nd Avenue adjacent to 211 S.W. Ankeny Street for a sidewalk cafe, and declaring an emergency." is hereby repealed.

ORDINANCE No.

Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary ordinances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
