

ORDINANCE No. 150925

An Ordinance creating one position of Fire Inspector II and abolishing one position of Fire Inspector I within the Bureau of Fire, Prevention Division, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the individual assigned as the Bureau's Public Information Officer has recently been promoted to a Fire Inspector II.
2. That it is in the best interest of the Bureau of Fire to retain this individual in the administrative assignment as Public Information Officer and thereby retain continuity in relations with the media.
3. That the Chief of the Bureau of Fire has recommended and the Bureau of Personnel services has reviewed this action.

NOW, THEREFORE, the Council directs:

- a. The following position in the Bureau of Fire is abolished:

- b. The following position in the Bureau of Fire is created:


