## ORDINANCE No. 150926

An Ordinance creating one position of Fire Captain and abolishing one position of Chief Alarm Operator within the Bureau of Fire, Fire Alarm Dispatch Center, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That the current Chief Alarm Operator is retiring.
- That reclassification of this position to Fire Captain is necessary in order to provide a qualified replacement and will assist in making future appointments.
- 3. That no increase in appropriation is required for the execution of this action because the Chief Alarm Operator position is currently compensated at a rate equal to Fire Captain.
- 4. That the Chief of the Bureau of Fire has recommended and the Bureau of Personnel Services has reviewed this position change.
