# ORDINANCE NO. **15092**7

An Ordinance creating two positions of Clerical Specialist I and abolishing two positions of Secretarial Clerk II in the Bureau of Parks effective September 16, 1980, and declaring an emergency.

The City of Portland ordains:

## Section 1. The Council finds:

- 1. Two positions of Clerical Specialist I are required by the Bureau of Parks, one in the Recreation Director's office (RU 131) and one in Intake/Referral (RU 130).
- 2. These positions are presently classified as Secretarial Clerk II positions. Due to the type of duties these positions involve, reclassification to Clerical Specialist I is appropriate for both positions.
- 3. Two positions of Secretarial Clerk II can be abolished to provide the appropriation for the positions being created. No additional appropriation is required for the reclassification action.
- 4. This reclassification action was recommended by the Bureau of Personnel and adopted by the Civil Service Board on September 16, 1980.

### NOW, THEREFORE, the Council directs:

a. The following positions are created in the Bureau of Parks, AU 130, one in RU 130, Office of Superintendent, Intake-Referral, and one in RU 131, Recreation Division, Recreation Director's office, with salary rates in accordance with the current Compensation Plan:
