ORDINANCE NO. 151083

An Ordinance amending Title 3, Administration, of the Code of the City of Portland, Chapter 3.106, by enumerating the powers, duties and responsibilities of the Special Service Personnel of the Exposition-Recreation Commission, declaring such personnel to be special police for certain purposes, granting such personnel authority to enforce City Code sections 14.20.030, 14.20.060, 14.20.080, 16.20.020, 16.20.030 and 16.04.020, in connection with the operation of the Exposition-Recreation Commission facilities; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Exposition-Recreation Commission's operation of the Memorial Coliseum Complex and the Civic Stadium attracts large numbers of vehicles and pedestrians to events conducted at those facilities.
- 2. The Commission employs approximately 55 people in its Special Services Department to maintain control of the crowds attending these events.
- 3. The lack of power and authority on the part of the Commission's Special Services Personnel to make arrests and issue citations for violations of certain provisions of the Code hampers their ability to maintain crowd control at the Commission's facilities.

NOW, THEREFORE, the Council directs:

a. Title 3, Chapter 3.106, Exposition-Recreation Commission, of the Code of the City of Portland, Oregon, is amended as follows:

"EXPOSITION-RECREATION COMMISSION

(Added by Ord. No. 143806 passed and effective June 15, 1977.)

- 3.106.020 Filing copies of resolutions with city auditor.
- 3.106.030 Council review.
- 3.106.040 Exposition-Recreation commission action not subject to council review.
- 3.106.050 Council initiation of Exposition-Recreation commission action.
- 3.106.060 Amendment, repeal or alterations of resolutions by council.
- 3.106.070 Special services personnel as special police.

"3.106.070 special services personnel as special police. Persons appointed as special services personnel shall be special police officers of the city and shall so serve. As special police officers, the special services personnel and the supervisor, shall have authority to issue citations for violations of parking or non-moving traffic violations occurring on the Memorial Coliseum Complex premises and the Civic Stadium premises, and particularly they shall have authority to issue citations as provided for in section 16.06.060, and shall have authority to sign citation forms as provided for in section 16.06.010. In addition to authority to issue citations for parking or non-moving traffic violations, special services personnel and their supervisors shall have authority to issue citations for violations of 14.20.030, 14.20.060 and 14.20.080 occurring on the Memorial Coliseum Complex premises and the Civic Stadium premises. To the extent of the power and authority granted in this section, such personnel and their supervisors shall exercise full police power and authority."

Section 2. The Council declares that an emergency exists because the power and authority granted in this Ordinance are necessary to aid in crowd control at the Commission's facilities; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
