ORDINANCE No. 151085

An Ordinance amending Section 5.52.010 of the Code of the City of Portland to increase the petty cash account for the Business Operations Office of the Bureau of Water Works from \$400 to \$800, authorizing a warrant for \$400, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The current petty cash account in the amount of \$400 in the form of cash established by the City Treasurer in the name of the Business Operations Office, Bureau of Water Works, is no longer adequate to meet the Bureau's operating needs without frequent reimbursement.
- There is sufficient appropriation in the 1980-81 Water Fund budget and the Administrator of the Bureau of Water Works has requested the Business Operations Petty Cash be increased to \$800.

NOW, THEREFORE, The Council directs:

a. Section 5.52.010 of the Code of the City of Portland is hereby amended as follows:

WATER FUND (Water Bureau)

Business Operations Office

\$ 800.00

- b. The Mayor and the Auditor are hereby directed to draw and deliver a warrant in the amount of \$400 to the Bureau of Nater Works; said warrant to be charged to the Bureau of Water Works Appropriation, RU 181, Object Code 490 (Miscellaneous), BUC No. 18100011.
- Section 2. The Council declares that an emergency exists in order that there may be no unnecessary delay in increasing the petty cash account of the Business Operations Office of the Bureau of Water Works; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
