

## ORDINANCE No. 150931

An Ordinance creating one position of Associate Accountant and abolishing one position of Accounting Assistant in the Bureau of Police, Fiscal Administration Division, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. One position of Associate Accountant is required by the Bureau of Police.
2. The Bureau of Police has requested a review of the position of Accounting Assistant and Civil Service has determined that the job requirements are those of an Associate Accountant.
3. One Accounting Assistant position can be abolished to provide partial appropriation for the position being created.
4. The necessary additional appropriation will be provided by salary savings within the Fiscal Administration Division.

NOW, THEREFORE, the Council directs:

- a. The following position is created in the Bureau of Police with a salary rate in accordance with the current Compensation Plan:

- b. The following position in this Bureau is abolished:



The Council declares that an emergency exists because the position to be created is immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
